# **GENERAL PRINCIPLES:**

BAZZANA SRL, through this Code of Ethics, intends to make explicit those values and behavioral principles that it has always been committed to respecting by demanding mutual observance of them from all stakeholders involved in the business reality itself.

# SCOPE OF APPLICATION AND ADDRESSEES:

The Company is committed to assuring employees, customers, suppliers, business, and financial partners that all company activities will be carried out in full compliance with the law, constituting with this Code of Ethics a code of conduct exemplifying the general obligations of integrity, diligence, fairness, loyalty, and transparency that go to affect the entire corporate sphere.

## **BASIC ETHICAL PRINCIPLES:**

The management of human resources involved in BAZZANA SRL must be based not only on compliance with the provisions in force in the country in which it operates, but also on respect for the individual as an individual without discrimination of race, gender, religion, sexual orientation, geographic origin, age, social class, disability, political opinion, and union membership.

BAZZANA SRL is committed to ensuring, according to the provisions of the law, that its workers respect working hours and the regular recognition of overtime.

Remuneration must allow its employees to live in dignity, ensuring that it is in line with the provisions of the law in force.

### Freedom of association

It is guaranteed to all workers without fear of restriction or interference.
